

Bridal Makeup Policies - Makeup by Kayla Maree

- **PAYMENT/PRICING**

- All payments to *Makeup by Kayla Maree* must be paid by the contract holder.
- Additions to the makeup schedule must be paid in full at time of add-on.
- All quotes are valid for 7 days. If a contract is not signed or accepted within this time, a new quote will be required.
- A non-refundable retainer is due immediately after signing the contract.
- 50% of the grand total is required to book services.
- Your remaining balance is due IN CASH the day of your event, once makeup services are complete.
- Contracts that are accepted and signed within one week of the wedding date, must be paid in full.

- **CANCELLATION:**

- You may cancel your services at any time. Upon cancellation, the contract holder will forfeit all payments made. All payments made to *Makeup by Kayla Maree* are non-refundable and non-transferable.
- Should *Makeup by Kayla Maree* be unable to perform services for the contract date, a full refund will be issued. Refunds consist of all payments made by the contract holder.

- **TRAVEL/ACCOMMODATIONS:**

- One way travel fees of \$1-\$1.50 per mile from address to address will be applied.
- Events that require 2.5 or more hours of one-way travel will incur additional fees for hotel accommodations. Variable and to be agreed upon by the contract holder and *Makeup by Kayla Maree* at time of contract signing.
- Destination wedding fees differ and are evaluated on a case-by-case basis.
- Contract holder is responsible for all parking expenses charged to *Makeup by Kayla Maree*

- **MAKEUP TRIALS:**

- If you book a makeup trial separately before booking wedding day makeup services with me, a non-refundable \$20 retainer is due to schedule the trial.
- Booking just a makeup trial alone does NOT secure your wedding date, and is subject to be booked without a wedding day makeup service contract in place.
- If your wedding date gets booked up within the time frame of booking your trial and your trial date, your \$20 deposit will be refunded and no longer be held.
- If you would like to ensure your wedding date is booked and held with me, you will have to fill out a wedding day makeup booking form, sign a makeup service contract and place a deposit.

- **LIABILITY:**

- All tools, and makeup products are sanitized between every makeup application.
- All skin conditions should be reported to the makeup artist prior to application.
- *Makeup by Kayla Maree* is not responsible for any potential allergic reactions to makeup and other products used. *A detailed list of ingredients is available upon request.*
- For safety reasons, the contract holder acknowledges *Makeup by Kayla Maree* may alter or NOT perform services should a client present with contagious infections or illnesses. Including but not limited to: Conjunctivitis (pink eye), COVID, Cold sores/fever blisters.

- **ADDITIONAL FEES:**

Early departure fee.

Makeup assistant fee: \$100+

Holiday weekend fee.

Additions to the makeup schedule 7 days or less from event and day of event additions.
